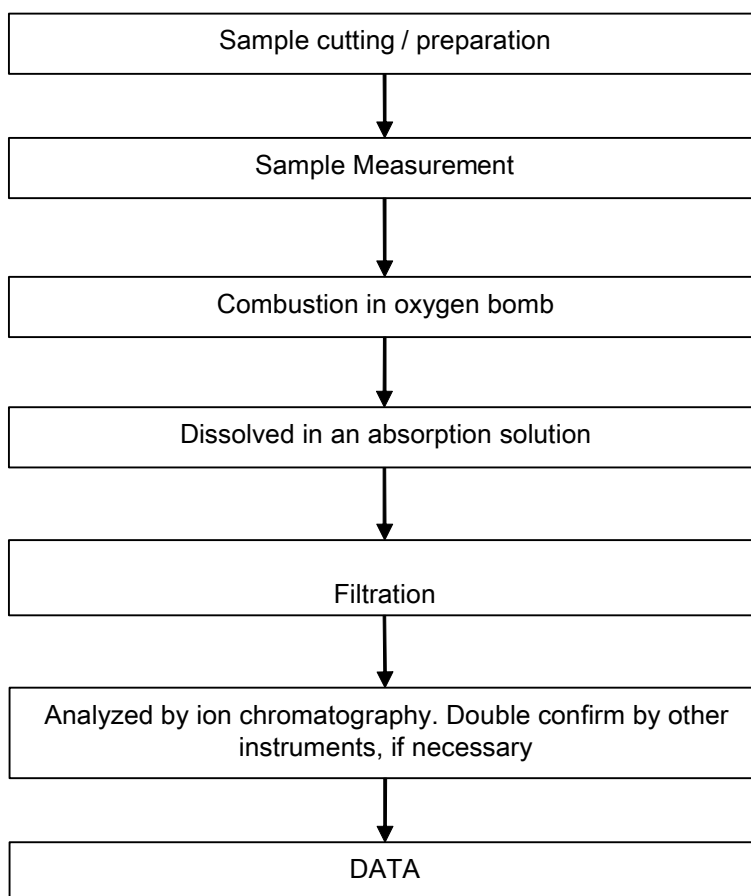

Halogen Testing Flow Chart

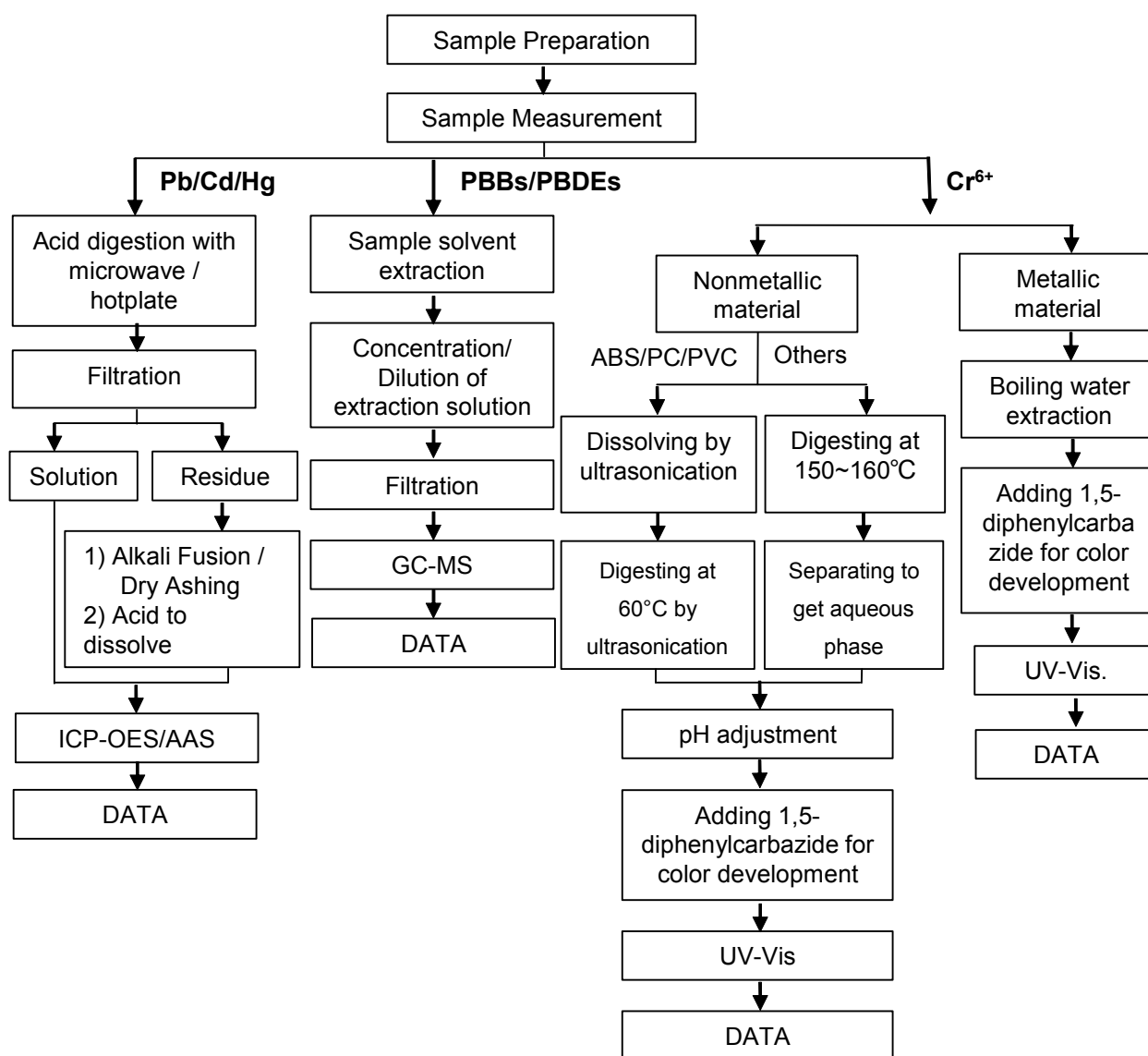

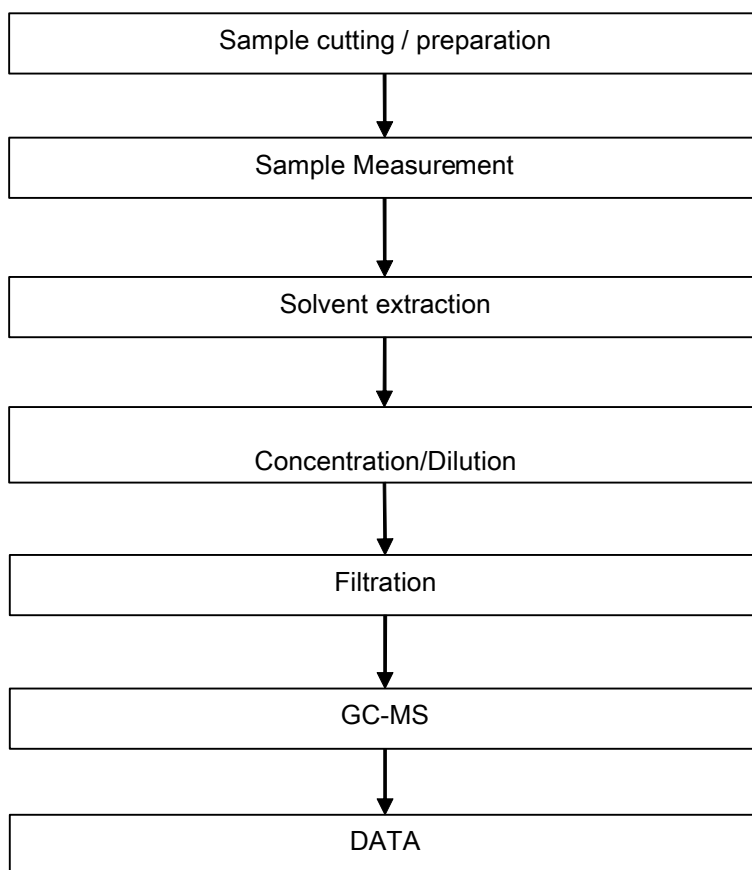

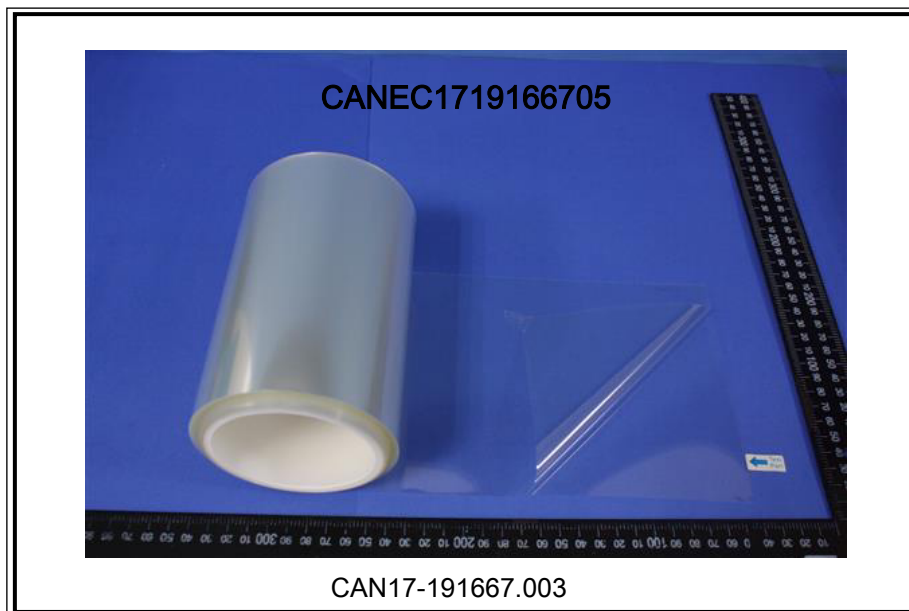
